Subject : Report.

Sir,

With due regards, I beg to state that today on 09/12/2023 at about 3:55 a.m received a reliable information that some unknown armed miscreants have stored and hidden some arms, ammunitions and explosives in the jungle of Salam Patong village near Church for using offensive act against State Security Forces and CAPF.

On receipt of the information, Special Operation Group (SOG) Thoubal District Police along with COB Somrei, 33 AR led by Addl. SP(Ops)/TBL assisted by OC/CDO-TBL under the supervision of Sr. SP/TBL have rushed to the spot immediately and launched a massive operation at 5:00 am by using metal detectors. On searching and found the undernoted articles i.e. (i) 1(one) No. of 7.62mm SLR Rifle bearing registration number 18058672, (ii) 1(one) No. of 303 Mark-III Rifle bearing registration number 78075 K along with 1 (one) magazine, (iii) 2 (two) Nos. of 36 HE Hand Grenade with detonator, (iv) 2(two) Nos. of Chinese Walkie talkie set, (v) 3(three) Nos. of 40 mm Lathode Bomb, (vi) 2(two) Nos. of arm ring, (vii) 1(one) No. of Tube Launcher, (viii) 5(five) Nos. of Stun Shell, (ix) 1(one) No. of tear Smoke shell, (x) 1(one) No. of Stringer Hand Grenade (Verischak) and (xi) 1 (one) No. of Grenade key from the spot at 6:30 a.m. And further seized the aforesaid articles at 7:00 a.m by observing necessary formalities. The massive searched Operation was conducted from 5:00 a.m to 7:30 am on the same day.

So it is therefore, handed over the seized articles to you for your kind consideration and further necessary action.
