Rajen Singh of Churachandpur Khuga Tampak A/P Yourabung Khunou and evacuated to Raj Medicity Hospital, Imphal but K. Tonsana was succumbed to his injury.

Hence a sou mottu case under FIR No. 144(0)2023 LLI-PS U/s- 304-A IPC and 27 Arms Act has been registered for investigation.
