Sir,

I have the honour to report that on 22/8/2023 at about 4:30 pm when I was at the Office of SDPO-Lamlai, Porompat for investigation in c/w FIR No.. 32(7)2023,LLI-PS U/S-148/149/364/34 IPC & 25(1-A) Arms Act added 302 IPC, 3(2)(v) of the scheduled Tribes(Prevention of Atrocities) Act, 5 nos. of unknown miscreants armed with fire-arms entered my residential house at Pourabi Makha Leikai and asked my wife about my whereabouts. They further told my wife that I am responsible for exaggerating the case FIR NO. 32(7)2023,LLI-PS(Killing of Lucy Maring) by adding more stringent sections/Acts and making it difficult for the accused persons to be released on bail. They further threatened my wife saying that they will kill me if the accused persons do not get bail. .

I, therefore request you to kindly take-up necessary legal action against the unknown armed persons.
