Sir,

I am to report that today i.e the 28th August, 2023 at about 3:30 pm received reliable information from 4 AR corroborated with our own intelligence regarding the transportation od arms and ammunitions at Sawombung area along Imphal-Ukhrul road. Based on the said information, a team of CDO/IE along with a column of 4 AR led by myself under the command of Shri Kh. Herojit , MPS, Addl. SP(Ops) Imphal East and under the supervision of Shri Ksh. Shivakanta Singh, IPS, Superintendent of Police Imphal East District rushed to the said area and conducted a random frisking and checking to the suspected passersby. In that one suspected vehicle coming from Lamlong Bazar side, was detained for verification at Sawombung Forest Gate. On verification, the detainee identified himself as one Shiningson chilhang (52)yrs S/O- (L) Mathotmi Chilhang of Laikoiching village, Senapati District. On checking the detainee body, one wallet was found and recovered. On checking the car (Maruti Alto 800) there found one 9 mm SMG carbine loaded with five live rounds in the magazine. On further verification, the detainee stated that the above recovered 9 mm SMG Carbine was bought today i.e. 28th August 2023 from one unknown person at the cost of 1,00,000/- (one Lakh rupees) through one of his associates namely Mr. Ramkui Tangkhul from Khamson village, Ukhrul at Dewlahland, Imphal West. So, the detainee was arrrrested from the spot i.e. Sawombung Forest Gate at 4. 30 pm by observing due formalities. One 9 mm SMG Carbine marked as ' J0767, SAF1967 with butt No. 127, loaded with five rounds in the magazine, one car, white in colour, (Maruti Suzuki Alto 800) bearing regd. No. MN 09A/0384 having Engine No. F8DN5961697 and chasis No. MA3EUA61S00C047829 and one wallet containing a sum of Rs. 200/- (Two hundred rupees) and one Driving License were seized from his possession by observing formalities from the spot i.e. Sawombung Forest Gate at 4.40 pm.

On further verification, the arrestee stated that he joined the said outfit NSCN (IM) in the year 1994 and presently working under the command of one S/S- Deputy Kilonser Mr. Canan Kasar of NSCN (IM):

Therefore, the arrestee persons along with the seized items are being handed over to you for taking up further necessary legal procedures against him.
