Sir.

With due regards, I have the honour to state that today i.e. 18/03/2023 at about 11:45 am, as usual a combined teams of CDO-BPR, NBL-PS and a column of 16 AR (Maibam post) were conducting mobile vehicle checking post (MVCP) led by self assisted by ASI H. Robash Singh, CDO BPR, Hav. No.1194122, Md. Rafik, Hav. No.1197666 Md. Salamad Shah at Langpok village near playground along Phadibi road.

While doing so at around 12:35 pm, one Maruti Alto car Maroon in colour bearing regd. No. WB66J-0924 which was proceeding from Kakyai Langpok crossing side towards Nambol Chingmang side along Phadibi road was detained for verification. On spot verification, the driver and two occupants identified themselves as (i) Md. Khutleibam Amirkhan (39) S/o Late Md. Hellaluddin of Lilong Tairen Makhong, PO&PS-Lilong, Thoubal District, Manipur (driver of the vehicle), (ii) Md. Sengamayum Nasiruddin (26) S/o Md. Maniruddin of Lilong Chingkham Makha, PO&PS-Lilong, Thoubal District, Manipur and (iii) Md. Khulakpam Tenden (20) S/o Md. Sallaoddin of Lilong Ushoipokpi, PO&PS-Lilong, Thoubal District, Manipur. Due to their suspicious nature and in order to check their body and belongings, they were given option whether they wanted to check their bodies and belongings in front of a Gazetted Officer or Magistrate. In that they opted to be searched in presence of Executive Magistrate. Accordingly, contacted concern Executive Magistrate Shri M. Binbin, SDC/Executive Magistrate, Nambol. Thereafter, the Executive Magistrate reached within a short period at the spot and their bodies and belongings were searched and checked minutely. While checking the vehicle, one black bag containing five packets of plastic polythene filled with powdery substances were found concealed at the front passenger floorboard, which is highly suspected to be contraband brown sugar. Immediately, a weighing machine was brought from the nearby locality shop and properly weighed the polythene packets which weight 1.026 Kg marked as "A", 1.015 kg marked as "B", 1.031 Kg marked as "C", 1.031 Kg marked as "D" and 1.024 Kg marked as "E" respectively total weight about 5.127 kgs including the weight of plastic packet and sealed at the spot by observing necessary formalities. On preliminary interrogation of the detainees, they disclosed that they are drug peddlers and the said items are contraband Brown sugar which was brought from one Mr. James of Yaingangpokpi for selling to some prospective buyer in and around Nambol area.

So, the suspected contraband brown sugar were seized in presence of the Magistrate at 1.30 pm and one Maruti Alto car Maroon in colour bearing regd. No. WB66J-0924 along with 6 (six) nos. of Mobile Phones were seized at 1.35 pm from their possession.

Accordingly, the accused persons were arrested at 1.40 pm, 1.42 pm and 1:45 pm respectively from the spot by observing necessary formalities and handed over to Nambol Police Station along with the seized items for taking further necessary action.
