With due respect, I the undersigned namely Thiyam Inaobi age about 45 years, resident of Churachandpur Nghathal Meitei Leikai beg to submit the following few lines for your consideration and necessary action.

That on may-03-2023 at about 7:00 p.m some unknown persons numbering about 400 to 500 belonging paite and zomies community started attacking the Meitei Persbyterian Church there after the so called group of people started destroying and burning the Meitei church resulting in all the properties of the church were razed to the ground and all the belongings items were stolen before damages/burning.

In the light of the above facts and circumstance, it is therefore respectfully requested that your good self may cause the arrest of the miscreants who belongs to the Paite-Zomi community involved in burning/ dismantling/damaging my properties and take up FIR against them as soon as possible. In the interest of justice and urge to the concern authorities to compensate for those who expired and damaged all the properties belongs. List of items to be compensated are shown as Annexure.
