Subject: - Complaint/ Report on the crimes of **looting, vandalism, arson attack and discrimination of Scheduled Tribes.**

Dear Sir/Madam,

With reference to the above cited subject, I have the honour to report to you as follows:

1. That, I am a widowed wife of an Ex-Serviceman, drawing the Family Pension of my deceased husband **No. 4338260 Late Jangkhopao Kuki of 4 Assam Regt. vide PPO No. S/31880/ 77.** I am a Scheduled Tribe belonging to the Any Kuki Tribe, which is a recognized Tribe under the Constitution of India. And, I am a permanent resident of Saiton Khunou, P.O., P.S. & District- Churachandpur, Manipur.
2. That, on the **3rd of May, 2023, at about 11:00 PM,** a huge contingent of armed radical Meitei/ Meeteis suspected to be members of the Arambai Tenggol and Meitei Leepun attacked our village and in the process, they have looted, vandalized and torched my house.
3. That, it may be reported here that the miscreants were shouting slogans like- "**KANGLEIPAK YAIPHARE**"; "**KUKI HATLO**"; "**HAO HATLO**"; etc. while they were carrying out their criminal activities. It seems to me that all these has taken place at the instance of the Manipur State Government as the perpetrators openly claimed and shouted that nobody would stop them, even the police because everyone, including top officials of the Manipur Government are patronizing them and that that no harm could be done to them.
4. That, at the time of the attack we somehow managed to escape to save our lives under the compelling circumstances and thus could not take our belongings to safety and were all burnt. A list of our properties looted/ destroyed/ burnt is attached here under with its estimated costs. The total loss suffered is estimated to be about **Rs. 1,01,90,000/- (Rupees One Crore One Lakh Ninety Thousand) only.**

5. That, I am filing this report lately because we were at different places for safety and now since we have started to settle at a rented house at Hmar Veng, P.O., P.S. & District- Churachandpur, Manipur, I am filing the same today with a prayer to accept it though filed lately.

In the given circumstances, I humbly pray you to kindly register an FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
