Subject: - First Information Report on the crimes of looting, vandalism, arson attack and discrimination of Scheduled Tribes.

Dear Sir,

With reference to the above cited subject, I have the honour to report to you as follows:

That, I Kimnei aged about 72 years w/o (L) Ngamjahao belonging to the Anykuki Tribe, a recognized Scheduled Tribe under the Constitution of India. And, I am a permanent resident of Saiton Khunou Village, P.S. Churachandpur District-Churachandpur, Manipur.

That, on the 3rd May at about 11:20 PM, a huge contingent of armed radical Meitei/ Meetei suspected to be Meeitei leepun and Arambai Tenggol led by Manipur State forces like the Manipur Police Commando/the Indian Reserved Battalion (IRB) attacked our village and in the process, they have looted, vandalized and burnt down our house and properties including our livestock, my son's machinery equipment used for construction of houses and welding machine.

That, it may also be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be Rs 32,80,000/- (Rupees Thirty two lakh Eighty thousand) only.

Fortunately, I and my family managed to escaped from these criminals who even tried to kill or burn us alive and now taking refuge in relatives house at Molnom Jubilee Veng, Molnom, Churachandpur.

My delayed in filing reports may be exempted due to my prior Information in this regards given was untraceable till today.

In the given circumstances, I humbly pray you to kindly register an FIR investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
