**Subject:-** First Information Report on the crimes of looting, vandalism, arson attack and discrimination of Scheduled Tribes.

Dear Sir/Madam,

With reference to the above cited subject, I have the honour to report to you as follows:

1. That, I am a Scheduled Tribe belonging to the Zou Tribe, a recognized Scheduled Tribe under the Constitution of India. And, I am a permanent resident of HIANGZOU village ... P. S. District - Churachandpur Manipur
2. That, on the 4th May, 2023, at about 08:00 AM / PM, a huge contingent of unknown mob attacked our village and in the process, they have looted, vandalized and torched my house. The list of destroyed materials is attached here under with its estimated costs.
3. That, at the time of the attack we somehow managed to escape to save our lives under the compelling circumstances. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be Rs 505,000 (Rupees five lakhs five thousands) only.
4. That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health, and, thus I am filing the complaint today.

In the given circumstances, I humbly pray you to kindly register an FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
