**Subject:** - Report on house caught on fire caused by an unknown-mob located at Hiango Village, P.O., P.S. & District-Churachandpur-795128.

Dear Sir,

With reference to the above cited subject, I have the honour to report to you as follows:

That, I am a Scheduled Tribe belonging to the Zou Tribe, which is a recognized Tribe under the Constitution of India.

That, on the 4<sup>th</sup> of May, 2023, at about 12:30 PM, due to the ethnic crisis in the State of Manipur, some unknown-mob torched my neighbor's house belonging to the Meeitei/Meitei community and in the process, the fire caught my house which is semi-wooden, located at Hiango Village (near Mandop Leikai), P.O., P.S. & District-Churachandpur, which got burned down to ashes along with all the properties in it, such as *holdhold items, electronics appliances, personal belongings, etc.* estimated to be worth Rs.21,95,600/- (Rupees Twenty-One Lakhs Ninety-Five Thousand Six Hundred) Only.

Therefore, I am filing this report lately as I was not aware of the existence of FIR until now, so, I humbly pray you to kindly register a FIR and investigate the matter as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged. Thus, I am filing the report lately today.
