I, Vastl/Lhingneihat age about 28 years w/o Seitintong Lenthang a resident of Saiton Khunou P.O & P.S Churachandpur, District Churachenndpur presently staying at Molso Phai Kapinang Saiton Khunou P.O & P.S Churachandpur, District Churachenndpur would like to report that at the onset of communal violence in Manipur I along with my family have left our Village for our own safety leaving behind all properties and being at the boarder it was attacked on the 4th May 2023 at around 2:30 am by Meitei miscreant who vandalize and burnt the down the whole village.

That, this wanton arson has left us with mental agony and personal material loss estimated to be at a value of Rs. 2500000/- (Rupees Twenty Five Lakhs only) including of Semi-Pucca House, Furniture, House Hold Goods and Livestock.

And that I am not able to file this report on time due to my frequent shifting of place and am out of station for a while.

I, Therefore would like to request your kind office to negate my delayed and initiate necessary action at the earliest for the end of justice.

For which kind act of yours I will remain thankful to you.
