With due respect, I, the undersigned namely A.
KHUMDONBI CHANU aged about 53 years, resident of D. PAALIE
beg to submit the following few lines for your kind consideration
and necessary action.

A) That, I and my family members are victims of the present
unrest that occurred from 03-05-2023 onwards.

B) That, on 3/5/2023, at about 7:30 pm, some unknown
persons numbering about 300 belonging to Kuki community
started attacking the undersigned along with my children
and other family members, some unknown armed miscreant
attacked my house, physically assaulted my family
members including myself and destroyed household
properties worth around Rs. 5,65,000 (Rupees - Five
lakh sixty five thousand) approximately.

C) That, the unknown miscreants are suspected to be
of the Kuki dialect while physically assaulting my
family and destroying my household properties. The said

turned down my residential house, two private vehicle and other household items which are given in the list enclosed along with this report.

D) That, the unknown armed miscreants warned and threatened my family members and myself to leave the village permanently and that we will face dire consequences if we return to our village again. Delay of filing FIR is due to displacement and uncertainty of relief camp. In view of the facts and circumstances I shall be very grateful if your goodself would kindly initiate appropriate steps for identifying the unknown arms miscreants, apprehend them and punish them in accordance with law.

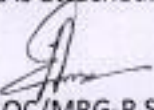
