1. That, I and my family members are victims of the present unrest that occurred from 03/05/2023 onwards.

2. That, on 3rd May at around 3:50 pm while I was at my residence situated at Churachandpur Khugadampak. Some unknown armed miscreants attacked my Beauty Parlour. And destroyed my properties worth around Rs 4 lakh.

3. That, the unknown miscreants are suspected to be the Kuki tribe as they conversed among themselves in the Kuki dialect while physically my family and destroying my properties. The said unknown armed miscreants also set on fire and burned down my Beauty Parlour.

4. That, the unknown armed miscreants warned and threatened to leave the village permanently and we will face dire consequence if we return to our village again.
