Respected Sir,

I, the undersigned beg to report for your kind and necessary action. That I and my family members are victim of the present unrest that occurred from the 3rd of May 2023.

On 3rd May around 4:30 pm, while I was at home along with my family members consisting myself, my wife, children and other family members, some unknown armed miscreants attacked my house, physically assaulted my family members and myself, destroyed household properties worth around ₹ 12,000,00 (Twelve lakhs only) approx.

The unknown miscreants suspected to be of the Kuki tribe as they conversed among themselves in the Kuki dialect while physically assaulting my family. The said unknown armed miscreants also set on fire and burned down my residential house, 1 private vehicle and other household items which are given in the list enclosed along with the report.

That the unknown armed miscreants warned and threatened me and my family members to leave my village and that we will face dire consequences if we return to our village again. Delay of filing F.I.R is due to displacements and uncertainty of relief camps.

In view of the facts and circumstances, I shall be very grateful if you would kindly initiate appropriate steps for identifying the unknown miscreants, apprehend them and punish them in accordance to law.



