Subject: Report of attacked on religious property.

Sir,

I, Haokholun Kuki age about 64 years of age S/O Doukhojam Kuki a permanent resident of Saiton Khunou P.O & P.S Churachandpur, District Churachandpur presently staying at Zion Veng, Tuibuong P.O & P.S Churachandpur was a Head Deacon of Kuki Baptist Church (KBC) Gambi No.25 that on the 3rd May 2023 at around 11:45pm due to ethnic violence between the Meitei and Kuki -Zo Community, Meitei Leepun and Arambai Tangol led by State Police Commando who came from Hayaikon, P.S. Moirang, Bishnupur District using around 9 armored vehicle attack our village and burnt down everything in it.

That, in this wanton arson attacked our Local Kuki Baptist Church (KBC) Gambi No.25 at Saiton Khunou, Churachandpur was also burn to ashes with all its furniture and materials used for worship purpose which may amount to a value of about Rs. 6,592,000/- (Rupees Sixty Five Lakhs Ninety Two Thousand only) which include of Church Building, Sound System and Church Material and that I am filing this reports lately due to my ignorance in giving the same towards attack on place of Worship.

I, Therefore would like to request your kind office to negate my delayed and initiate necessary action at the earliest for the end of justice.

For which kind act of yours I will remain thankful to you.
