With due respect, I, the undersigned namely Laisram Kuber Singh aged about 43 Years, resident of Khuga Tampak Meitei Likai beg to submit the following few lines for your kind consideration and necessary action.

That on 04/05/23 at about 6:30 A.M., some unknown persons numbering about 200+ belonging to Kuki Community started attacking the undersigned along with family members. Thereafter, the Kuki people started destroying and burning the house of the undersigned resulting in all the properties of the undersigned were razed to the ground and all the belongings and jewelleryes were also burned/destroyed/stolen before burning/demolished.

In the said incident was badly injured due to pelting of stones/hacking with knife/shot from firearms towards us by the miscreants.

A separate sheet showing the particulars of all the losses incurred by me is attached along with the present application.


