Sir,

I would like to report that on 04/05/2023 at around 3:00pm my residential house located at Kangvai Village, Charachandpur was ransacked, vandalized, looted and completely burnt down by unknown Meitei miscreants numbering about 100. All the properties within the house - Rs 62,00,000 (in hard cash), 82 bags of grains, furniture, household items, clothings, utensils etc were all burnt down with the house. The estimate value of the burnt assets/properties is estimated to be around Rs 90,19,600 approx.

In this regard I would like to request you to kindly take up necessary legal action against the unknown Meitei miscreants at the earliest.
