Subject :- Report on Looting, Vandalism of household items/assets and Documents

Madam/Sir

With reference to the above cited subject I have the honour to report to you as follows :

1. That I **Nengkhothang Vaiphei** aged about 70 years H/o **Hatthiannei Vaiphei** Belonging to the Vaiphei Tribe / Community, a schedule Tribe recognized under the constitution of India , by virtue of which I am being entitled to the protection under **The SC/ST (Prevention of Atrocities) Act, 1989**, and that I am a permanent resident of **Kangvai Bazar Jubilee Veng ,PO/P S- Churachandpur**.
2. That at about **4 pm** on the **3rd May 2023**, a huge contingent of armed radical meitei/Meitei suspected to be members of the Arambai Tengol and Meitei Leepun along Meitei mob numbering about 500 attacked our locality so me and my family have to run for our lives and in the process, they have looted, my house as well as our livestock.
3. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred a huge loss which may be estimated to be **Rs. 1500000 (Rupees Fifteen Lakhs)** only
4. Fortunately, me and my family managed to escaped from the criminals who even tried to even kill us, and took shelter at Assam Rifles Camp at Kangvai, and eventually shifted to our relatives place at Kangvai Khopi Veng.
5. That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and settled at My relative place Churachandpur. And ,thus I am filing the report lately today.

In the given circumstances, I humbly pray you kindly register an **FIR/ZERO FIR** , investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And , for which act of kindness, I shall always remain thankful to you and obliged.
