Respected Sir,

I, the undersigned beg to report for your kind, necessary action.

That I and my family members are victims of the present unrest that occurred from 03-05-2023 onwards.

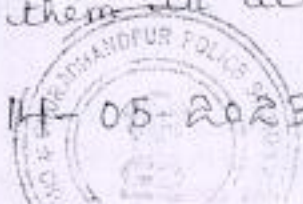
At around 4:30 p.m. while I was staying at home along with my family members, some unknown armed miscreants suspected to be of the Kuki tribe as they conversed among themselves in the Kuki dialect started attacking us and assaulted us and destroyed household properties worth around Rs 50,00,000/- (Rupees Fifty lakhs only) approximately.

The unknown armed miscreants also set my residential house on fire. They attacked us with guns, sticks and stones. While running away I was hit by a stone on my leg. Other valuable items lost are given in the list enclosed along with the report.

The unknown armed miscreants also warned and threatened me and my family to leave the village permanently and that we will face dire consequences if we don't oblige. Delay of filing an F.I.R is due to displacement and uncertainty of relief camp.

In view of the facts and circumstances, I shall be very grateful if you would kindly initiate appropriate steps for identifying the unknown armed miscreants, apprehend them and punish them in accordance with the law.
