

I have the honour to report that, I am born and brought up at Old Bazar, CC-Pur, District, Manipur and living with my family of 4 members. I am businessman. On i.e. 04/05/2023 at around 7:00 am. two of my Grocery shop including house at Old Bazar CC-Pur. District was looted by the some Kuki tribes rioters by holding gun, sword, stick etc. Grocery items worth 15,00,000/- lakhs and my house comprising of 5 rooms was looted by some Kuki rioters by holding Gun, sword, stick, etc. 4 Nos. of Cooking Gas cylinder, Some Golds ornament worth Rs. 1,00,000/- (One Lakh) and Rs. 4,00,000/- lakhs in cash including many important document viz. Registration certificate of vehicles and many more. all the house hold items including 3 Godrejs, 3 bed, Tv flat, Washing machine, VIP Sofa, two activa (Two wheelers) etc. AR deployed at CC-Pur help my family escaped from there brutal and merciless acts. Their illegal act lead many properties turned into ashes and disturbing peace and tranquillities to the general public heavily.

It is therefore required you to kindly take up necessary action against those Kuki tribes rioters for their Illegal and brutal acts as per law.


