Sir,

With due respect, I beg you to register a FIR regarding loss and damage for properties due to the ongoing communal crashes in Manipur.

I had been residing at the resident of Mr. Angom Angou Singh aged about 70-year-old S/o (L) A. Tolchou Singh, a resident of D. Phailien Lemaram Leikai, Churachandpur, Manipur, since the last 3 years. I've been positing at Moirang Vet. Hospital as V.O and I used to look after the various activities carried out by the staffs under Moirang Sub-Division.

On 3rd May, 2023, at about 6.30 p.m, I luckily escaped from the attacks carries out by the kuki miscreants and later I took shelter at the camp of 36 A.R. Churachandpur for 6 days. The lists of the victims were officially recorded by the concerned authority before safety deportation to different destinations. The miscreants/attackers ransacked the rented room robbing everthing whatever available there including - a sum of Rs 30,000,00/- (Rupees thirty lacs), household materials. And also burnt down an i-20 Hyundai car bearing registration No. MN 06LA8635 along with the house. The total value of the loss items is approximately Rs 40,000,00/- (Rupees forty lacs) only excluding the house.

It will very humble and respectful, if you kindly register my complaint for necessary action. Thanking you.
