Construction Rent house... on private vehicles and other household items which are given in the list enclosed along with this report.
- 4. That, the unknown armed miscreants warned and threatened my family members and myself to leave the village permanently and that we will face dire consequences if we return to our village again. Delay of filing an F.I.R is due to displacement and uncertainty of relief camp/place.

In view of the facts and circumstances, I shall be very grateful if your goodself would kindly initiate appropriate steps for identifying the unknown armed miscreants, apprehended them and punish them in accordance with law.
