That on 04-05-2023, at about 11:45 A.M some unknown
persons numbering about 200, belonging to Kuki community
attacking the undersigned along with family members.
Thereafter, The KUKI people started destroying and burning
the house of the undersigned resulting in all the properties of the
undersigned were razed to the ground and all the belonging and
jewelries were also burned / destroyed / stolen before burning /
damage.

A separate sheet showing the particulars of all the losses
incurred by me is attached along with the present application.

In the above facts and circumstances, it is therefore respectfully
requested that your good self may cause the arrest of the
miscreants who belongs to the Kuki community involved in the
burning / dismantling / damaging my properties and taken up an
FIR against them as soon as possible for the interest of justice.
