With reference to the above cited subject I have the honour to report to you as follows :

1. That I **Thualkhanthang** aged about 60 years S/o (L) **Soitinlel** Belonging to the Vaiphei Tribe / Community, a schedule Tribe recognized under the constitution of India , by virtue of which I am being entitled to the protection under **The SC/ST (Prevention of Atrocities) Act, 1989**, and that I am a permanent resident of **S Buoljang Village Churachandpur**.
2. That at about **7 pm** on the **27th may 2023**, Some Unknown Mob burnt down my house as well all my household items.
3. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred a huge loss which may be estimated to be **Rs. 200000 (Rupees Two lakhs) only**
4. Fortunately, me and my family managed to escaped and now currently taking refuge at my partially burnt down house at **S Buoljang Village Churachandpur**.

In the given circumstances, I humbly pray you kindly register an **FIR/ZERO FIR** , investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And , for which act of kindness, I shall always remain thankful to you and obliged.
