I, the undersigned beg to report for kind and necessary action.

1. That, I and my family members are victims of the present unrest that occurred from 03-05-2023 onwards.

2. That on 3-05-2023 at around 9 a.m./p.m., while I was at my residence situated at Thingangfai P.O. Kanapui (S.P.) P.S. Kanapui District Churachandpur Manipur along with my family members consisting of myself, my husband/wife, children and other family members, some unknown armed miscreants attacked my house, physically assaulted my family members including myself and destroyed household properties worth around Rs. 16 L.R. (Siala) Lakhs (Ten thousand) (Rupees 16 Lakhs) approximately.

3. That, the unknown miscreants are suspected to be of the Kuki tribe as they conversed among themselves in the Kuki dialect while firing and physically assaulting my family and destroying my household properties. The said unknown armed miscreants also set on fire and burned down my residential house, grocery shop, Pan-bell (oil), etc. long then... San. San. & others with private vehicles and other household items which are given in the list enclosed along with this report.

4. That, the unknown armed miscreants warned and threatened my family members and myself to leave the village permanently and that we will face dire consequences if we return to our village again. Delay of filing an F.I.R is due to displacement and uncertainty of relief camp/place.

In view of the facts and circumstances, I shall be very grateful if your goodself would kindly initiate appropriate steps for identifying the unknown armed miscreants, apprehended them and punish them in accordance with law.


