Subject: - Firs: Information Report on the crimes of looting and discrimination of Scheduled Tribes.

Dear Sir,

With reference to the above cited subject, I have the honour to report to you as follows:

That, I Niangmuankim aged about 37 years W/o Kamhau Vaiphei belonging to the Vaiphei Tribe, a recognized Scheduled Tribe under the Constitution of India. And, I am a permanent resident of Kangvai Village, P.S. Churachandpur District- Churachandpur, Manipur.

That, on the 3rd May at about 3:00 PM, a huge contingent of armed radical Meitei/ Meetei suspected to be Meeitei leepun and Arambai Tenggol led by Manipur State forces like the Manipur Police Commando/the Indian Reserved Battalion (IRB) attacked our village and burnt down our neighbouring houses, fearing for our lives we escaped to take refuge at Kangvai Assam Rifle camp for about 10 days hoping to go back to our own village yet due to the continuous violence breakout we deserted our home unable to go back.

That, it may also be reported that on 10th August 2023 around 8:00 pm I, am informed that our deserted home has been looted during the above said criminal activities causing grave mental agony and incurred huge loss which may be estimated to be Rs 15,00,000/(Rupees Fifteen lakh) only.

Fortunately, I and my family managed to escaped from these criminals who even tried to kill or burn us alive and now taking refuge at Bethel Area, Dorcas Veng, New Lamka Churachandpur.

In the given circumstances, I humbly pray you to kindly register an FIR investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
