Sir,

I have the honour to report that on 8/11/2023 at about 8:25 pm, one scooter Honda Activa bearing regd. no. MN04G2046 ridden by my nephew Ningthoujam Sanathoi Singh aged about 25 yrs s/o N. Arkey Singh of Khangabok Part I Sanilou Leikai met a self accident at Khangabok Khullakpam Leikai near Charu Mandop along Khangabok IVR in order to divert one dog that was ran accross the road in front of his scooter while he was proceeding towards Khangabok Lamlong Bazar. As a result of it, my nephew sustained severe injuries and his scooter was also partly damaged. The injured person was evacuated to District Hospital, Thoubal for medical treatment and undergoing further treatment at Raj Medicity, Imphal West.
