

**Subject: Injury Report.**

Sir,

With due respect, I Pauginmuan Guite age about 25 years S/O (L) Tuangkhanpau a resident of Tangnuam Village, Saikot T.D. Block P.O.& P.S. Churachandpur would like to report that on the fateful night of the 3<sup>rd</sup> May 2023 at around 8:00pm while I was passing through Thengra Leirak, Hill Town Churachandpur, Manipur and due to the ethnic violence which already started some people believed to be of Meitei militant taking shelter in that area started to shot indiscriminately toward Red-Cross Lane, Thengra Leirak Junction Hill Town, Churachandpur in which I was hit by bullet fired from their arms causing multiple injury to my body where 17(seventeen) pellets were stuck in various parts of my body. Some people from nearby immediately rushed me to District Hospital Churachandpur, from where I was referred to Guwahati, Assam for better medical care due to the grievousness and complications of my wound.

And, that I am filing this report lately after returning from Guwahati, Assam where I was taken for medical treatment.

Therefore I would like to pray that your kind office may initiate necessary action so, that those culprits may be booked under the provision Law for the end of Justice.
