Today i.e on 11/11/2023 at 04.00 pm received an information that on the same day at around 3.50 pm, one motorcycle Vespa bearing regd. No.MN01AD-8801 ridden by unknown rider which was coming from Thoubal Ningombam towards Thoubal Bazar and another one Honda Activa 6G bearing regd. No.MN01AJ-7366 ridden by unknown rider which was coming from opposite direction, collided with each other along MI road near Laikon, Thoubal Nongangkhang due to rash & negligent driving of the both unknown riders. As a result of which two riders and pillions of the both vehicles sustained injuries on their persons and evacuated to hospital for medical treatment. Both the 2-wheeler vehicles were also partly damaged.

Hence, a suo-motu case under FIR No.191(11)2023 TBL-PS U/s 279/338/427 IPC has been registered for investigation.
