Subject: Report.

I have the honour to report that today i.e. 24/03/2023 at around 03:30 pm based on input from 16 AR that some contraband items are being transported from Churachandpur to Dimapur, a combined team of Commando Unit Thoubal led by Inspector K. Nitarnan Singh, Officer-in-Charge Commando Unit, Thoubal assisted by HC Th. Sanatomba Singh including a column of 16 AR and under the supervision of Shri. Jogeshchandra Haobijam, IPS, Senior Superintendent of Police, Thoubal District, Manipur conducted frisking and checking along NH-2 Leimaram Lamkhai under Nambol Police jurisdiction. During frisking and checking, one Nissan Kicks white in colour bearing Registration No. ML 10C 4537 was seen coming from Churachandpur side towards Imphal side in a suspicious manner. On seeing the suspicious behaviour, the team stopped the Nissan Kicks and detained it at 04:00 pm for verification.

On verification, the unknown driver identified himself as David Basumatary (41 yrs) s/o Sudhir Basumatary of 4th Mile, Diphupar Dimapur, Nagaland and other occupant of the said SUV identified himself as Moa Lkr (40 yrs) s/o Chungshi Lkr of 4th Mile, Diphupar Dimapur, Nagaland. As their behaviour became more suspicious that they were suspected to have been concealing of contraband items and the option was given whether they would want their bodies and the SUV to be searched in presence of a Magistrate or a Gazetted officer. In that, they opted their bodies and the SUV to be searched in presence of Gazetted officer. Accordingly I informed to O. Wangkhomba, MPS, Addl. SP(Ops), Thoubal at 04:15 pm to be witness during the search who arrived at 05:15 pm at the spot. In presence of O. Wangkhomba, MPS, Addl. SP(Ops), Thoubal who is a gazetted officer conducted a thorough checking of the persons and SUV. On body searched of David Basumatary (41 yrs) s/o Sudhir Basumatary, our team found one Redmi 10 Pro with 2 (two) SIM cards i.e. Airtel SIM bearing mobile No. 8132997369 and Jio SIM card bearing mobile No. 7005325380 and one money purse black in colour with one Aadhaar card issued in the name of David Basumatary bearing No. 3879 1238 5730 and a sum of Rs. 1800/- (one thousand eight hundred) only (i.e. Rs. 500X3 and Rs. 100X3) and on checking of Moa Lkr found one Oppo A15 with 2 (two) SIM cards i.e. Airtel SIM bearing mobile No. 9131039829 and Jio SIM card bearing mobile No. 7005707803 .

Further on thorough checking of the SUV found 20 (twenty) soap cases containing suspected Heroin Brown Sugar concealed inside the spare tyre of the SUV. Afterwards the 20 (twenty) soap cases suspected to Heroin Brown Sugar were marked as "A1", "A2", "A3", "A4", "A5", "A6", "A7", "A8", "A9", "A10", "A11", "A12", "A13", "A14", "A15", "A16", "A17", "A18", "A19" and "A20" respectively for identification and weighed by using weighing machine and found 1. 39 gms, 2. 39 gms, 3. 41 gms, 4. 43 gms, 5. 45 gms, 6. 43 gms, 7. 42 gms, 8. 40 gms, 9. 42 gms, 10. 39 gms, 11. 41 gms, 12. 41

gms, 13. 38 gms, 14. 44 gms, 15. 43 gms, 16. 40 gms, 17. 42 gms, 18. 41 gms, 19. 42 gms and 20. 38 gms respectively including the weight of the transparent plastic and soap cases, the total weight is 823 gms.

Accordingly, David Basumatary (41 yrs) s/o Sudhir Basumatary of 4th Mile, Diphupar Dimapur, Nagaland and Moa Lkr (40 yrs) s/o Chungshi Lkr of 4th Mile, Diphupar Dimapur, Nagaland were arrested at the spot at 05:30 pm and 05:35 pm respectively by observing formalities.

On further examination David Basumatary (41 yrs) s/o Sudhir Basumatary of 4th Mile, Diphupar Dimapur, Nagaland revealed that the said suspected Heroin Brown Sugar were taken by him from one Lingboi of Churachandpur District, further revealed that the said consignment was loaded and concealed by Lingboi of Churachandpur District inside the Nissan Kicks.

Hence, the above contraband items, one Redmi 10 Pro with 2 (two) SIM cards i.e. Airtel SIM bearing mobile No. 8132997369 and Jio SIM card bearing mobile No. 7005325380, money purse black in colour with one Aadhaar card issued in the name of David Basumatary bearing No. 3879 1238 5730 and a sum of Rs. 1800/- (one thousand eight hundred) only (i.e. Rs. 500X3 and Rs. 100X3) and Nissan Kicks white in colour bearing Registration No. ML 10C 4537 were seized on production and from the possession of David Basumatary (41 yrs) s/o Sudhir Basumatary of 4th Mile, Diphupar Dimapur, Nagaland at 06:00 pm of 24/03/2023 by observing formalities. Further, one Oppo A15 with 2 (two) SIM cards i.e. Airtel SIM bearing mobile No. 9131039829 and Jio SIM card bearing mobile No. 7005707803 were seized from the possession of Moa Lkr (40 yrs) s/o Chungshi Lkr of 4th Mile, Diphupar Dimapur, Nagaland at 06:05 pm of 24/03/2023 by observing formalities.

Thereafter, all the above seized articles along with arrested persons are handed over to you for taking further necessary legal action.
