Sir,

With due respect, I, the undersigned namely Huidrom Chandramani aged about 78 Years, resident of Khuga Tampak Meitei Leikai beg to submit the following few lines for your kind consideration and necessary action.

That on 03/05/23, at about 5:00 PM, some unknown persons numbering about 500 belonging to Kuki Community started attacking the undersigned along with family members. Thereafter, the Kuki people started destroying and burning the house of the undersigned resulting in all the properties of the undersigned were razed to the ground and all the belongings and jewelleryes were also burned/destroyed/stolen before burning/demolished.

In the said incident Huidrom Pishak was badly injured due to pelting of stones/hacking with knife/shot from firearms towards us by the miscreants.

A separate sheet showing the particulars of all the losses incurred by me is attached along with the present application.

In the above facts and circumstances, it is therefore respectfully requested that your goodself may cause the arrest of the miscreants who belongs to the Kuki community involved in the burning/dismantling/ damaging my properties and injuring ..... and take up an FIR against them as soon as possible for the interest of justice.

Brief Clinical Note The patient was referred from CHC, Moirang for further management after a/h/o sustaining a gunshot injury on Lt chest on 3/5/2023 at around 9:00pm. Routine blood investigations done, E-fore - Neg, NECT Thorax shows Lt upper lobe of lung contusion. Exploration and retrieval of pellet was done & LA from Rt sided chest wall on 4/5/23 in Emergency OT. No post-operative complications. CXR-PAV repeated on 6/5/2023 and patient was stable at the time of discharge.

Recommendation/advice Adv - To review in CTUS OPD (Fri, 2pm) after 1 week  
- Regular dressing with betadine solution
