IN THE MATTER OF - -

Complaint made under Section 190 of the Code of Criminal Procedure, 1973, against the above-named Accused person for committing offences Punishable under sections 420 IPC.

- Place of occurrence:-

At the Sangaiyumpham within Thoubal Police Station, Manipur.

- Date and Time occurrence:-

06.06.2023, and still continue.

The Complainant above-named respectfully states as under:-

1. That the Complainant is born, brought up and permanently residing in the State of Manipur and he is also a law abiding citizen of India. Accordingly, he is entitled to all the protection and safeguard guaranteed under the Constitution of India and other Acts and Rules.



2. That accused Laishram Ranjit Singh, a football Coach of the Boyka Academy based in Bangaluru, approached to Md. Samaskhan who is son of the Complainant, and offered that he can admit Md. Samaskhan to KF SHKODRA, ALBENIA @ KLUBI FUTBOLLIT SHKODRA, ALBENIA, a football academy in Albania, and he will take care for the Passport, Visa, etc.
3. That Laishram Ranjit Singh also promised that if Complainant's son Md. Samaskhan failed to meet the bench² mark and criteria of the aforesaid academy during his initial stage at Albania, he shall re-admit the Complainant's son Md. Samaskhan to any reputed football academy in India
4. That Laishram Ranjit Singh had asked Rs.2,00,000/- (Rupees Two Lakhs only) to Complainant for the overall expenditure in admitting his son Md. Samaskhan in the aforesaid academy, and the Complainant accepted the same and handed-over the aforesaid amount of Rs.2,00,000/- (Rupees Two Lakhs only) to Laishram Ranjit Singh on 06.06.2023 at the house of the Complaint in the presence of family members, and more particularly, the 2 (two) attesting witnesses of Deed of Agreement dated 06.06.2023 executed by the accused person in favour of the Complainant .
6. That accused Ranjit further told to the Complainant that his son and other player will stationed at KOMPLEKSI SPORT IV ZMIJANI, SHKODER BOYKA ACADEMY, Bangaluru, for a month under the full supervision of the accused Ranjit. Thereafter, Complainant's son and 2 other players left Manipur for Bangaluru on 07.06.2023, when Complainant's son

and 2 other players reached Bangaluru and they were put to a hotel in Bangaluru instead of agreed/promised place at Boyka Academy.

Thereafter, accused Ranjit told to Md. Samaskhan that his father presence is necessary to obtain the passport. Accordingly, Complainant came to Bangaluru on 07.07.2023 by Indigo flight being PNR No.MLQ9HL, and when Complainant reached there accused Ranjit again told the Complainant that his wife presence is also necessary to obtain the passport, as his son being a minor. Being suspicious to the act of accused Ranjit, Complainant asked him that he want to talk to whom Ranjit is communicating in Albania. Accused Ranjit refused and told the Complainant that he will returned the aforesaid amount of Rs.2,00,000/- (Rupees Two Lakhs only) on 10.07.2023 by 10:00 a.m.

7. That 09.07.2023, the Complainant along with his son and 2 (two) other players came to Guwahati by Air Asia flight being PNR No.IZVQQS, thereafter, from Guwahati to Imphal also by Air Asia flight being PNR No.EIM5KP, but accused Ranjit neither returned Complainant's aforesaid sum of Rs.2,00,000/- (Rupees Two Lakhs only) nor received his latest call till date. Instead accused Ranjit threaten the Complainant for dire consequences if he continue to ask for the aforesaid money. Complainant also came to know that the accused Ranjit also took Rs.2,00,000/- (Rupees Two Lakhs only) each from the other 2 (two) players fraudulently.

8. That being very much aggrieved with the crime and offences committed by the above named accused person, the Complainant submitted a



written report dated 23.08.2023 to the Officer-in-Charge, Thoubal Police Station, Manipur, with a humble request to take up appropriate action against the aforesaid Accused person. Thereafter, when no steps or action was taken up by the said O.C./TBL.P.S., the Complainant was compelled to again approach the S.P./Thoubal, Manipur, with a written report dated 18.09.2023 for taking up appropriate action against the said accused. However, till now no action has been taken up by the concern Police for reasons best known to them. Hence, the present case.

9. That being aggrieved by the offences committed against the Complainant by the Accused person, the Complainant has filed the present Complaint before the Hon'ble Court for directing the concerned Police to thoroughly investigate the matter after necessary arrest and/or for taking cognizance of the said offences and prays to render justice by imposing maximum penalty, after taking cognizance of the aforesaid offences and trial thereof.

PRAYER

It is, therefore, prayed that Your Honour may graciously be pleased :-

- i. to take cognizance of the offences committed by the Accused person,
- ii. to issue process either by summons or warrant of arrest against the Accused person, and
- iii. to prosecute and punish the said Accused person for the offences he had committed by imposing maximum sentence of imprisonment and maximum penal fine to the Accused person for the ends of justice,

- iv) to direct the concerned Police to register FIR Case and cause thorough investigation and inquiry by causing arrest of the accused person,
- in the interests of justice and public interest.

And the Complainant, as in duty bound, shall ever pray.
