Subject:- Report

Sir,

I have the honour to report that a large numbers of unidentified groups of people belonging to Kuki community holding with deadly weapons and sophisticated arms suspected to be Kuki militant groups stormed to all Meitei inhabitant area of Chongtham Leikai, Kangvai Bazaar, Churachandpur on 27th May 2023 at @ 6:30 pm. They looted all the valuable items kept therein and burnt down my house and the house of my uncle's namely, Thounaojam Thambaljao Singh (66)yrs S/o Th. Krishnamohan Singh of Chongtham Leikai, Kangvai Bazaar, Churachandpur. The total approximate value of the items that they have looted in the unfortunate incident from my house is about Rs. 4,00,000/- (Four lakhs) only. I could not submit the report in time due to present law and order situation of the state.

It is therefore, requested to take up necessary legal action against the accused persons as per law of the land.




