Subject: Report.

Sir,

I have the honour to report that today i.e. 25/11/2023 at @ 12:05 pm while my wife namely Khunrakpam Rani Devi (26) yrs was alone at my home, suddenly two unknown persons came at my house and sprayed an unknown liquid to my wife and my wife was unconscious. During that time, they had looted one necklace of gold about "5 sans", two finger rings of gold @ "2.5 sans" from my wife (rupees seventeen thousand per sañ) and also they had looted a sum of Rs. 2,50,000/- (rupees two lakhs fifty thousand) only by breaking locks of wooden Almirah which was kept inside my house. The approximate value of the looted items is Rs. 377,500/- (rupees three lakhs seventy seven thousand and five hundred) only.

It is, therefore, requested kindly take up necessary legal action regarding the matter.
