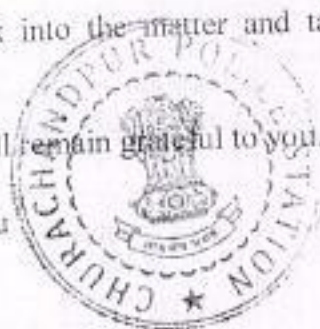
That, I with my family members have timely escaped from the accident of 3rd May, 2023 and we are living at the residence of my wife's house after reported to the Relief Camp at Ithai High School.

That my SBI Customer Services Point with a DTP works centre located at Tuibong, next to SP office, Churchandpur District and a rented house has been safely guarded by my house owner till 11th June, 2023 without any damaged. Unfortunately, on 12th June, 2023 @ 2:15 pm my services point/centre has been burn down by some unknown persons and the things within the centre were turned into ashes with all amount which was deposited by the customers i.e total estimated amount were Rs. 19,45,500/- (Rupees nineteen lakhs forty five thousand and five hundred only. I could not report in time to your good office because I could not get the information on time about this accident from Churchandpur on time about this accident from Churchandpur. I can get that news on yesterday night i.e 5th July, 2023 due to the present situation between the communities.

So, I therefore request you to kindly look into the matter and take necessary action in humanitarian ground.

For which act of your kindness, I will remain grateful to you.
