Sir,

With due regard and humble request, I have the honour to state that on 03/05/2023 at about 4:30 pm, some unknown person numbering about 1000 (one thousand) belonging to Kuki community started attacking us. Thereafter, the said unknown Kuki people looted all the household and other valuable properties i.e Jewellery, Cash and other valuable items and destroyed and burned down the house resulting in all the properties were razed to the ground. The approximate value of the looted items and properties losses in the incident is about 15,00,000 (fifteen lakh). Now, I am settle at the house of my brother in law namely Khoirom Madan (35) s/o Khoirom Ibochou located at Yurembam Awang Leikai, Imphal West.

In the above facts and circumstance, it is therefore respectfully requested that your goodself may cause the arrest of the miscreant who belong to the kuki community involved in the incident and take up an FIR against them as soon as possible for the interest of the justice. I couldn't report the incident in time due to present law and order situation of the State.
