With due respect, I the undersigned namely Labuktongbam (o) Tharoshang Devi (58) W/O Labuktongbam Okendro Sharma of Thengra Leirak, Churachandpur beg to submit the following few lines for your kind consideration and necessary action.

That on 03/05/2023 at about 11.30pm, some unknown arm persons numbering about 1000 belongs to kuki community started attacking at my resident. Thereafter the kuki people started destroying and burning my house and forcibly snatched my vehicles i.e. TVS Scooty(two wheeler) solo blue in colour B/regn.no.MN06SG1455 having Engine No.FG5DN270017 & Chassis No.MD626DG54N2 D00678 as well as one Hyundai Venue (1.2 sx) car Titan Grey in colour B/regn. No. MN01AW8235 having Engine No.G4LANM399580 & Chassis No.MALFD81BLPM420424 which were stand in the name of my husband namely Labuktongbam Okendro Sharma S/O L. Kondum Sharma of Thengra Leirak, Churachandpur.

In the above fact and circumstances, it is therefore respectfully requested that your good self-cause the arrest of the miscreants who belongs to the kuki community involved in the burning /dismantling / damaging / snatching of the said vehicles. So, kindly trace out the stolen vehicles and take up necessary legal action against the accused as soon as possible persons on the interest of justice.
