Respected Sir,

I, the undersigned beg to report for your kind and necessary action.

1. That, on 5th May 2023 at around 3:00 a.m/p.m, some unknown miscreants suspected to be Kuki tribes and Kuki militants stormed our locality with arms and other incrimination weapons. They have fire and torched my residential House/Sangoi/Vehicle(s)/Cattles/Poultry/Household items/Furniture(s)/Food items/Jewellery items along with other valuable items.

2. That, the value of lost/damaged properties is around Rs. 7,62,500/- (Rupees Seven lakh Sixty two thousand) approximately.

3. That, the unknown armed miscreants warned and threatened me and my family members to leave the village permanently and that we will face dire consequences if we return to our village again.

4. That I could not report well in time due to the present law orther situation as well as displaced and standed I am taking shelter at Wangoo Nongyai Khong Mapai fromis 04/05/2023 along with my 7 family members till that.

It is therefore requested to take up necessary action with law against the unknown miscreants suspected to be kuki tribes and kuki militants.




