Sir,

I have the honour to state that on last 3/05/2023 at around 6:30 am/pm, large number of innumerable unidentified groups of people belonging to Kuki community with deadly weapons and sophisticated arms including Kuki militants groups stormed to all Meitei inhabited areas of Thengla Leikai. The said unidentified groups burnt down our house, /Shop and looted all the valuable items. In that unfortunate incident, I have lost a total amount of Rs. 1.200000 (in word one crore two lakhs) approximately. Their illegal act lead many properties turned into ashes and disturbing peace and tranquillities to the general public heavily.

It is, Therefore, prayed that the respected Sir may kindly initiate and take necessary legal action(s) against the accused persons and the persons involved in the said inhuman acts and heinous crime committed by the accused persons and persons involved as per law of the land as early as possible.

I shall be grateful for your kind co-operation and necessary actions (s).
