

I, the undersigned have the honour to state the following few lines for your kind consideration and further necessary action.

That, a large number of unidentified groups of people belonging to Kuki community with deadly weapons and sophisticated arms including Kuki militants groups stormed to all Meitei inhabited areas of Churachandpur Town on 3<sup>rd</sup> day of May 2023 at around 6:50 pm. They started destroying, looting and burning down the houses and house hold properties of Meitei community at our village located at Thengra Leirak, Churachandpur. In that, they caused damage, set on fire and looted the remaining valuable items of my house and grocery shop. Thereafter, the unknown armed miscreants warned and threatened my family members and myself to leave the village permanently and if fail their direction, I along with my family will have to face serious consequences. Due to fear and panic, I along with my family left our home and now taking shelter at the Relief Camp, Mekola Gulap Higher Secondary School. I could not report well in time as I was undergone medical treatment at and displacement and uncertainty of relief camp.
