Sir,

I, the undersigned have the honour to state that a large number of unidentified people belonging to the Kuki community with deadly weapons and sophisticated arms including Kuki militant groups stormed the Meitei inhabited areas of Thengra leirak, red cross road, Churchandpur-P.S. on 3rd day of May, 2023 at about 7:30 Pm. The said unidentified groups looted our household materials as well as shop and tent house materials and burnt down our house, shop and tent house. In such terrible acts of the said unidentified groups, I along with my family members ran away from Thengra leirak, red cross road, Churchandpur, to save our life and took shelter at different places. And started staying at the relief camp of Kamakhya Pemton College, Hiyangthang since 13/5/2023. In that unfortunate incident I have lost my house, shop and tent house and property amounting to a total amount of Rs:- 1.5 crore/- (one crore and fifty lakhs) approximately.

It is therefore, requested kindly initiate and take necessary legal actions against the accused persons involved in the said inhuman and barbarous act, as per law of the land as early as possible. I couldn't able to submit my complain report in time due to prevailing inconvenient situation.




