Subject:- Request for lodging of FIR case regarding looting and ransacking/burnt down of my house, grocery shop and two wheeler workshop located at Churachandpur on 3rd May 2023.

Sir,

I, the undersigned have the honour to lay down the following few line for your kind perusal and further necessary action please, that large number of innumerable unidentified groups of people belonging to Kuki community with deadly weapons and sophisticated arms including kuki militants groups stormed to all Meitei inhabited areas of Churachandpur Thengra Leirak area on 3rd day of May 2023 at around 7:00 pm. The said unidentified groups vandalised/burnt down my house including my grocery shop and two wheeler workshop and looted all valuable items. In that unfortunate incident, I have lost a total amount of Rs. 2 crore. After the said unfortunate incident/mob violent, my family are fleeing our village and my family is taking shelter at the house of my relative located at Heinoukhongnembi Konjeng Leikai.

It is, therefore, requested you to take up necessary legal action against the accused persons and the persons involved in the said inhuman acts and heinous crime committed by the accused persons as per law.

I shall be grateful for your kind co-operation and necessary actions (s).
