Dear Sir/ Madam,

With due respect, I, the undersigned beg to say that I am a permanent resident of Zoveng Zenhang Lamka CCpur but now displaced and staying at the relief camp at Wangoo Ahallup Mayai Leikai. I further beg to inform you that on 04/05/2023 at @ 5:00pm my house located at Zoveng Zenhang Lamka CCpur has been burnt down by gun toting Kuki whom I believe to be Kuki militants who are under suspension of Operation (SoO) and my properties worth 54,33,000/- (Rupees fifty four lakhs and thirty three thousand) of rupees have been looted by the Kuki. I could not report to the Police Station in time due to present unrest situation.

I therefore request you to kindly take up necessary legal action against these criminals and restore my properties.


