Sir,

With due respect, I the undersigned have the honor to report that I am working under the NHIDCL project name: "Restoration/Rehabilitation of Churachandpur - Tipaimukh road of (NH-150) from Km 9.00 to Km 70.00 (Total Length - 61Km) in State of Manipur - 2nd Call". But due to sudden outbreak of the crisis starting from 03/05/2023 which lead to mob violence and mass destruction of properties, Luckily our workers, Drivers and official staff of our project were all running and shifted to safety area but we could not bring back our project materials including Bitumen, Aggregates, Diesel, Office Furniture and others documents and has been continue till now in our Site Office and hotmix plant location: i.e. **Thinangphai, Emanuel Khopi Road, Opposite Churachandpur FCI Godown.** The area and hotmix plant was used on hire basis from land owner S Khampinthat from Zouvang near Khumujamba village.

Unfortunately, we are unable to report earlier due to unstable laws and orders of Manipur at that time, but recently we have received an information that truly state that our project materials which are left behind were lost and some of them were taken away by Kuki militant between date 28/05/2023 and 10/08/2023. All the materials lost or taken away are amounting to Rupees: 82, 69,732 (Eighty-Two Lakhs Sixty-Nine thousand Only)
