With due respect, I am to report that on 3rd May 2023 at about 9:00 pm my rented house located at Churachandpur Khuga Tampat (owner name Ningthoujam Naba Meiki) was set on fire and gutted in ashes by a large number of Kuki tribe and militants. The approximate value of the rented room and other household item is about 8.5 Lakhs. Due to law and order situation I could not submit the report to the concerned police station. I along with my family members are coming back in my native village Andro Sanapat, Imphal East Manipur.

It is therefore requested to take necessary action against the culprits according to law.
