Subject:- Damaged report in c/w the Blazing of property occurred on 03/05/2023 at Salem Veng Churachandpur, PO/PS- Churachandpur, District-CCPur by the Kuki militants.

Sir,

I the undersigned have the honour to state that and made this written report for your kind necessary action.

1. That, on 03/05/2023 at about 08:45 pm some unknown miscreants suspected to be ^{Kuki} militants and members of ATSUM stormed my locality with arms and other incriminating weapons at Salem Veng Churachandpur District where I was staying in a rented pucca building since 13 years back. They have fired and touched my said rented pucca house and burnt all my household items/Furniture(s)/Food items/jewellery along with other valuable properties.
2. That, the value of lost/damaged properties is around Rs. 13,42,000/- (thirteen Lakhs forty two thousand) approximately.
3. That, I could not report well in time due to the present law & order situation as well as I am displaced and stranded. I am taking shelter at Kakching Khunou Hijam Angom Leikai Relief camp from 4th May, 2023 till date. The name and particulars of damage properties are given below in a separate sheet.

It is therefore, requested to take up necessary action in accordance with law against the unknown miscreants suspected to be Kuki tribes, Kuki militants, and ATSUM.


