With due respect, I have the honour to report the following few lines that on 3rd May, 2023 at around 8:00 pm, all my properties were looted and my house was burnt down by large number of unknown persons belonging to Kuki community by holding deadly weapons and sophisticated arms, backed/supported by suspected armed kuki militants who stormed Meitei/Meetei inhabited areas and villages. The said unknown armed group had trespass my house and vandalized many property, looted many valuable properties like furniture items, kitchen items, utensil items, clothing, electronic items, gold, cash i.e Rs 12.5 lakh, two vehicles. Also burnt down my house & Hotel located at Hingol Marup Zenhang Lamka, Churachandpur. The approximate value that were burnt down/looted/vandalized of my property is about Rs One crore.

There is delay in filing the application as I along with my family members were fleeing for survival and we are currently taking shelter at NSCB (Residential School) Lamboikhongnagkhong, Imphal West.

In this connection, I humbly request you to kindly initiate and take up necessary legal action against the above mentioned culprits.

For this act of kindness, I shall remain ever grateful to you.
