Subject :- Request for lodging of FIR case regarding looting and
vandalized of my rental house located at CCPUR.

Sir,

I, the undersigned have the honour to state that large number of innumerable unidentified group of people belonging to kuki community with deadly weapons and sophisticated arms including kuki Militant Group(s) stormed to all Meitei inhabited areas of CCPUR town on 4th and 5th May, 2023. I am a physically handicap person and I have been staying at CCPUR working as Security Guard at St. Stephen English School, D Phallen, CCPUR. On 4th May, 2023 I and my family members fled from CCPUR saving our life leaving behind all my properties and belongings and were taking shelter at a relief camp situated at Usombung, Moirang, Manipur. Further we reached at Khurai Thangjam Leikai, Imphal East, I have not been able to report in time because I was busy in arrangement of our settlement at Khurai Thangjam Leikai, Imphal East. Later it came to know that on 8th July, 2023 my rental house at CCPUR had been looted and vandalized by some unknown Kuki groups.

It is, therefore, requested to kindly take necessary legal action against the accused persons and the persons involved in the said inhuman acts and heinous crime according to law.
