

I, the undersigned have the honour to state the following few lines for your kind consideration and further necessary action.

That, a large number of unidentified groups of people belonging to Kuki community with deadly weapons and sophisticated arms including Kuki militants groups stormed to all Meitei inhabited areas of Churachandpur Town on 3rd day of May 2023 at around 6:50 pm. They started destroying, looting and burning down the houses and house hold properties of Meitei community at our village located at Thengra Leirak, Churachandpur. In that, they caused damaged, set on fire and also looted the remaining valuable items of my rented house which belongs to Moirangthem Chandrahas Singh and one rented Tailoring shop which belongs to Kuki community located at Old Bazar, Churachandpur near the CCP Police Station. Thereafter, the unknown armed miscreants warned and threatened my family members and myself to leave the village permanently and that we will face dire consequences if we returned to our village again. Due to fear and panic, I along with my family left our home and now taking shelter at Relief Camp, SAI Complex, Utlou. I could not report well in time as I was heavily engaged in the medical treatment of my daughter Yaiphabi at RIMS Hospital, Imphal.
