I have the honour to state that on 03/05/2023 at around 6:20 pm, large number of innumerable unidentified groups of people belonging to Kuki community with deadly weapons and sophisticated arms including Kuki militants groups stormed to all Meitei inhabited areas of Thengra Leirak. The said unidentified groups burnt down our house and looted all the valuable items. In that unfortunate incident, I have lost a total amount of Rs. 26, 20, 000/- (Rupees twenty six lakhs and twenty thousand) approximately. Their illegal act lead many properties turned into ashes and disturbing peace and tranquilities to the general public heavily.

It is, therefore, prayed that the respected Sir may kindly initiate ad take necessary legal action(s) against the accused persons and the persons involved in the said inhuman acts and heinous crime committed by the accused persons and persons involved as per law of the land early as possible.

I shall be grateful for your kind co-operation and necessary actions.


